GENERAL ORDER

At its September 2022 session, the Judicial Conference of the United States increased the maximum per page original and copy transcript fee rates, effective October 1, 2023 (fiscal year 2024). A subsequent increase was also approved to go into effect on October 1, 2024 (fiscal year 2025).

Therefore, it is now ORDERED that pursuant to Title 28, United States Code Section 753(f), the following transcript rates per page are prescribed by the court, effective on October 1, 2023, and October 1, 2024, respectively. Transcripts ordered prior to the effective date of the revised rates should be billed at the rates in effect at the time the order was placed with the court reporter.


